Dr. Gayatri Singhal, Indian Program Manager, the United States-India Educational Foundation (USIEF) has informed as under vide e-mail letter dated 25.02.2021(copy enclosed)-

United States-India Educational Foundation (USIEF) has announced the **2021 Fulbright Distinguished Awards in Teaching Program for International Teachers (FDAI)** and invites applications from full time Indian teachers teaching any subject at any level (primary, middle or secondary) at a school in India. This program is also open to primary and secondary level library media specialists, guidance counselors, curriculum specialists, special education coordinators, and administrators who spend at least fifty percent of their time teaching or working directly with students.

**The program is only open for teachers working in the states of Andhra Pradesh, Odisha, Telangana, Karnataka, Kerala, Tamilnadu, Puducherry, Lakshadweep and Andaman Nicobar Islands, Chattisgarh, Goa, Gujarat, Madhya Pradesh, Maharashtra, Daman & Diu and Dadra & Nagar Haveli. This program is open only to teachers from the states mentioned above and not the rest of India.**

The program will provide with a unique opportunity to develop greater expertise in their subject areas, enhance their teaching skills, increase their knowledge about the United States, and complete an individual or group project. Participants will audit courses in the host university's school or department of education and thus will be part of the university community. The program will include opportunities to observe and co teach with US teachers in a US school near the host university, in order to actively engage participants in the US classroom environment. Cultural enrichment, mentoring and support will be provided through out the program.

**The duration of the program is August 2022 to December 2022.**


**The last date of submission of online application to USIEF is April 15 2021.**

The application should be submitted on-line to USIEF by the individual eligible and willing teachers. The printed copy of the on-line application (hard copy of the application should be submitted through proper channel (i.e. through R.O.) by the individual concerned. The regional offices after checking and verifying antecedents of the applicants should forward the applications to KVS (HQ) so as to reach this office by 19.04.2021.

The Deputy Commissioners are requested to check the antecedents of applicants especially vigilance clearance properly before recommending the cases to KVS (HQ).


